REGULATIONS OF THE STATUTE ENACTED

SHEMOTH (EXODUS) 21:12-36

¹² *“He who strikes a man so that he dies shall certainly be put to death.*

¹³ *“But if he did not lie in wait, but Elohim delivered him into his hand, then I shall appoint for you a place where he is to flee.*

¹⁴ *“But when a man acts presumptuously against his neighbour, to kill him by treachery, you are to take him even from My altar to die.*

¹⁵ *“And he who smites his father or his mother shall certainly be put to death..*

¹⁷ *“And he who curses his father or his mother shall certainly be put to death.*

¹⁸ *“And when men strive together, and one smites the other with a stone or with his fist, and he does not die but is confined to his bed,*

¹⁹ *if he rises again and walks about out-side with his staff, then he who smote him shall be innocent. He only pays for lost time and sees to it that he is completely healed.*

BEMIDBAR (NUMBERS) 35:6; 22-28

²² *‘But if he pushes him suddenly without enmity, or throws an object at him without lying in wait,*

²³ *or uses a stone, by which a man could die, throwing it at him without seeing him, so that he dies, while he was not his enemy or seeking his harm,*

²⁴ *then the congregation shall judge between him who killed someone and the revenger of blood, according to these right-rulings.*

²⁵ *‘And the congregation shall rescue the one who killed someone from the hand of the revenger of blood, and the congregation shall return him to the city of refuge where he had fled, and he shall remain there until the death of the high priest who was anointed with the set-apart oil.*

²⁶ *‘But if the one who killed someone at any time goes outside the limits of the city of refuge where he fled,*

²⁷ *and the revenger of blood finds him outside the limits of his city of refuge, and the revenger of blood kills him who killed someone, he is not guilty of blood,*

²⁸ *because he should have remained in his city of refuge until the death of the high priest. But after the death of the high priest he who killed someone is to return to the land of his possession.*

DEBARIM (DEUTERONOMY) 19:4-6

⁴ *“And this is the matter of the one who killed someone who flees there and live: He who smites his neighbour unintentionally, not having hated him in time past,*

⁵ *even he who goes to the forest with his neighbour to cut timber, and his hand swings a stroke with the axe to cut down the tree, and the head slips from the handle and strikes his neighbour so that he dies – let him flee to one of these cities and live,*

⁶ *lest the revenger of blood, while his displeasure is hot, pursue the one who killed someone and overtake him, because the way is long, and shall smite him, though he was not worthy of death, since he had not hated him before.*

YEHOSHUA (JOSHUA) 20:1-6

And יהושע spoke to Yehoshua, saying,

² *“Speak to the children of Yisra’el, saying, ‘Appoint for yourselves cities of refuge, of which I spoke to you through Mosheh,*

³for the slayer who kills any being accidentally, unintentionally, to flee there. And they shall be your refuge from the revenger of blood.

⁴‘And he shall flee to one of those cities, and stand at the entrance of the gate of the city, and declare his case in the hearing of the elders of that city. And they shall take him into the city as one of them, and give him a place, and he shall dwell among them.

⁵‘And when the revenger of blood pursues him, they do not give the slayer into his hand, because he smote his neighbour unintentionally, and did not hate him beforehand.

⁶‘And he shall dwell in that city until he stands before the congregation for right- ruling, and until the death of the one who is high priest in those days. Then let the slayer return and come to his own city and his own house, to the city from which he fled.’ ”
