REGULATIONS OF THE STATUTE ENACTED

MISHLE (PROVERBS) 28:24

AS AMENDED

By the authority of the assembly of affirmed American Nationals and the reign of the heavens World Government, and all Acts signed by the current United States, in Congress assembled are recognized by the assemblies in the various townships on the 7th day of October 2013.

It is strictly forbidden for any son or daughter to claim the inheritance of their father and mother before the death of their father and mother, otherwise is discerned as theft, and therefore the penalty for theft shall be the subject matter of the controversy to be resolved as amended in the 7th day of October 2013. However, power of attorney in the case of a disabled father and mother shall not be discerned as “claim of inheritance” although it is incumbent upon the son or daughter to preserve their inheritance for the sake of the father and mother to repay their father and mother for the debt of the son and daughter. If in fact, the inheritance of the son and daughter is squandered through power of attorney while the mother and father is still alive, it shall be the obligation of the son or daughter that did the squandering to support the mother and father until the death of their father and mother, otherwise suffer exile from the sphere of the reign of the heavens. Upon exile, any and all support shall come from the treasury of the reign of the heavens through the incun.1454.b5 account until the death of the father and mother so victimized.
